GHSP's New Electronic Grants Management System

Imagine having one place for your organization's grant documentation for your new GHSP grants; VTrans is proud to announce that the GHSP is going to make that dream a reality by offering an EGMS to our highway safety partners. The software is built by Agate IntelliGrants, and our system is named "GEARS" **Grant Electronic Application and Reporting System**.

We will be training our partners on how to use and apply for our awards in sessions in late March/early April for the FFY2018 application cycle. The staff will offer further trainings on how to submit FFY 2018 financial report forms and quarterly reports in August in GEARS. This federally funded NHTSA project will have a local benefit for your organization: saving staff administrative time, improving the delivery time of our services, all while improving error rates in the processing and tracking of documents.

An all-encompassing FFY2018 RFP will be emailed to potential Law Enforcement, Education Partners and the Traffic Records Coordinating Committee next week. We have been hard at work building a user friendly, intuitive EGMS that approved applicants will use for the entire life cycle of a GHSP award and beyond. "Report Out" from NHTSA for the 2016 Traffic Records Assessment

Following up from the article in the October / November Newsletter. Every five years, all states must undergo the National Highway Traffic Safety Administrations (NHTSA) Traffic Records (TR) Assessment to retain eligibility for State Traffic Safety *Information System Improvement Grant* (405C) funds. The assessment ensures that complete, accurate, and timely traffic safety data is collected, analyzed, and made available for decision-making at the national, state, and local levels.

Out of 391 assessment questions, Vermont met the Advisory ideal for 169 questions (43.2%), partially met the Advisory ideal for 49 questions (12.5%), and did not meet the Advisory ideal for 173 questions (44.2%).

Vermont met the criteria outlined in the *Traffic Records Program Assessment Advisory* 73.7% of the time for Traffic Records Coordinating Committee Management, 93.8% of the time for Strategic Planning, 63.6% of the time for Crash, 61.5% of the time for Vehicle, 55.6% of the time for Driver, 23.7% of the time for Roadway, 35.2% of the time for Citation / Adjudication, 26% of the time for EMS / Injury Surveillance, and 23.1% of the time for Data Use and Integration. *Vermont's overall score was 66.6% against the National average of 65.6%.*

Drunk Driving Facts

~On average, a drunk driver will drive under the influence 80 times before their first arrest.

~ Someone is injured in a drunk driving incident every 120 seconds.

~ Between 50 to 75% of the people who have had their licenses revoked due to driving under the influence drive illegally without their license.

~ Kids and teens who get involved with alcohol at a young age are 7 times more likely to be involved in an alcohol-related crash

Driver Behavior Paramount as Autonomous Vehicles Introduced

GHSA Report Spotlights Safety Challenges in Era of New Technology

WASHINGTON, D.C. – As autonomous vehicles (AVs) merge into our nation's traffic, the most pressing safety challenge for states will be preparing human drivers. While these vehicles have the potential for tremendous safety benefits, AVs will be sharing the road with traditional driver-operated cars for many decades, perhaps forever. And the public remains skeptical. Currently, only about one-fifth of drivers say they would buy an autonomous car as soon as one is available and fewer than one-third say they would be comfortable riding in one. This presents a myriad of safety challenges for states, which are responsible for educating the public, licensing drivers, and establishing and enforcing traffic laws.

The Governors Highway Safety Association's new report, [Autonomous Vehicles Meet Human Drivers: Traffic Safety Issues for States](#), examines these issues and recommends how states can prepare for AVs and put traffic safety at the forefront of all policy decisions. Dr. James Hedlund, a former senior official with the National Highway Traffic Safety Administration (NHTSA), authored the report.

According to Dr. Hedlund, "The research and media attention given to autonomous vehicles often overlooks the safety implications that a mix of driver-operated and autonomous vehicles will bring. Unfortunately, ignoring the driver side of the equation may negate many of the expected safety benefits."

The Association's report provides an overview of the current autonomous vehicle landscape and outlines suggested priorities for state Departments of Motor Vehicles (DMVs) and [State Highway Safety Offices](#) (SHSOs) as AVs become more widespread.
