


#### I. SHSO Highway Safety Plan Budget

- FHWA §164AL Transfer Funds are included in this graph.


#### II. SHSO Carry Forward Funds

- FFY21 Carry Forward funds are currently being evaluated by the SHSO and programmed in accordance with NHTSA's federal regulations using data driven decisions.


#### III. SHSO Expenditures All Projects


#### IV. SHSO Yearly Funding Awards
